- b) to establish, build, maintain and run and to aid in establishment, building, maintenance and running of homes for old, destitute and disable persons and to render financial assistance to any such institutions;
- c) To establish, maintain, run, develop, improve, extend, grant donations for and to aid and assist in the establishment, maintenance, running, development, improvement and extension of Libraries, Reading Rooms, Recreation Centres and all other facilities as are calculated to be of use in imparting education to the public in India.
